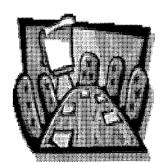

Attached is the 2014/2015 Amended Annual Budget Bylaw in the amount of \$12,721,746.

The Amended Annual Budget reflects the direction that was set for the education program in the annual budget. The Amended Budget includes changes that have occurred since the Annual Budget was adopted on May 21st, 2014.

The Amended Annual Budget Bylaw consists of three separate funds and they are:

Special Purpose Funds	\$425,218
Capital Fund	\$2,017,034

OPERATING FUND

Revenues and expenditures have been adjusted based on a combination of the final 2013/2014 Financial Statements and the 2014/2015 projections.

Several factors impacted the 2014/2015 projections including; the loss of revenues and saving of expenses resulting from the September job action, the milder than normal weather conditions to date, increases in utility charges, and benefit cost increases.

SPECIAL PURPOSE FUNDS

Special Purpose Funds are revenue and expenses that are separate from the regular operating funds and are restricted in their use. These targeted funds include Learning Improvement, Annual Facility, StrongStart, and Community Link grants.

CAPITAL FUND

The Capital Fund revenues and expenditures involve the amortization of the Deferred Capital Revenue and the amortization of Capital Assets for the year. These accounts recognize the depreciation of the facilities as well as bringing the Deferred Capital Revenue into the district's Amended Annual Budget for 2014/2015.

CONCLUSION

The Finance and Facilities Committee met on February 24th, 2015 to review these budget documents in detail. The Committee noted that the focus of the district continues to be on ensuring the protection of programs and services for students.

The Committee recommended that:

RECOMMENDATION:

"THAT the Board of Education give first, second and third reading and adoption to the attached 2014/15 Amended Annual Budget in the amount of \$12,721,746."
